New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

“We are determined to live under a State Government in the United States of America and under the Constitution of the United States”.

New California Declaration of Independence of

January 15, 2018 states:

“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security.

Preamble of the New California State Constitution states:

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Statement of Facts

The people of California are suffering from a tyrannical communist state government which fails to provide a republican form of governance, enables and supports across it's southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America. All caused by a government of and for a mono party system lead by a tyrannical dictator who openly defies federal law.

California State Government is in Direct Violation of the Following:

United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

CALIFORNIA STATE CONSTITUTION

ARTICLE I DECLARATION OF RIGHTS [SECTION 1 - SEC. 32]

(Article 1 adopted 1879.) [SECTION 1.](#)

All people are by nature free and independent and have inalienable rights. Among these are enjoying and defending life and liberty, acquiring, possessing, and protecting property, and pursuing and obtaining safety, happiness, and privacy.

MASS MURDER IS NOW THE ORDER OF THE DAY

The California communist governor the mono party government along their associates at the county and city levels are engaging in mass murder of United States Citizens living in the rural counties of California known as New California.

With the deaths and destruction of the community of Paradise in Butte county which occurred on November 8, 2018 it is obvious to those who have examined the evidence the fire which consumed the town killed as many as 100 people and left over 800 people missing was no “normal” fire.

The Camp Fire is still under investigation by “Cal Fire” but as with the majority of fires started in California we may never know what started this fire but rest assured the lie from the communist California governor that the culprit was climate change and global warming is the narrative he wants everyone to believe.

The facts are difficult to hide in the Paradise “Camp Fire” and the facts point to the direct involvement of the California communist governor, the mono party system, the state and local agencies and the media who have by their acts of commission created the instruments and circumstances which have led to the murder of hundreds of United States Citizens living in California. Some estimates for those who are missing place the number as high as 3,000.

Failure of the California communist governor and mono party system to clean and maintain rural California over the last eight years has not been for lack of desire by certain Citizens and even state units but by deliberate acts to let fuel build in all rural areas of California. By using his veto power the communist California governor stopped bills that would fund for the purpose of fire prevention in rural California. The same governor defunded numerous programs which their only function was to suppress fires by cleaning the forests and foothill areas.

Local officials not only in the Camp Fire but in the Car Fire and the Santa Rosa fires gave no advanced warnings of the fires once the fires started. We saw the same thing in the Oroville Dam disaster when the emergency was declared there was no way to alert the citizens. The reason was all the horns used at the fire stations in the evacuation areas were disconnected and there were no emergency message alerts.

Globalist ‘traffic calming’ plans were put into effect in Paradise several years before the Camp Fire which reduced from four lanes to two the exit routes out of town in the event of a fire. Acting as choke points and jamming traffic along the exit routes many people were burned alive in their cars.

The governor's Office of Emergency Services which is responsible for providing emergency services for displaced fire victims failed to provide any noticeable services thus leaving thousands of United States Citizen in California to the elements. After several days of being out in the elements fire victims including mothers with new born children became desperate as disease spread in the camps set up in vacant lots

Insurrection

The government of California, the current governor and mono party system along with local officials are following a coordinated design with the intent to actively engage in *acts of insurrection* against the U.S. Constitution.

The **Insurrection Act of 1807** is a [United States federal law](#) that governs the ability of the [President of the United States](#) to deploy [military troops](#) within the [United States](#) to put down [lawlessness insurrection](#), and [rebellion](#).

Illegal Acts and Tactics

Utilizing *Marxist-Leninist* and *Maoist revolutionary tactics* the communist California governor, mono party system and local government officials support and celebrate these tactics as a means to introduce and subvert all aspects of California government and civil society in an attempt to destroy the State of California and breakdown the sovereignty of the Union of States of America.

Acts of Secession
