Grievance 38

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

Article IV Section 3 United States Constitution states:

New States may be admitted by the Congress into this Union; but no new States shall be formed or erected within the [Jurisdiction](#) of any other State; nor any State be formed by the Junction of two or more States, or parts of States, without the Consent of the Legislatures of the States concerned as well as of the Congress.

Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

“We are determined to live under a State Government in the United States of America and under the Constitution of the United States”.

New California Declaration of Independence of

January 15, 2018 states:

“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security.

So it is the history of the past and present Governor and Government of California who have a history of repeated injuries and usurpations, all having in direct Object the establishment of a Tyranny over the Counties of New California and the State of California.

Whenever any Form of Government becomes destructive of these ends, it is the Right of the People to seek a constitutional remedy to the abuse of powers”.

Preamble of the New California State Constitution states:

*We, the representatives of the undersigned Counties within the State of California, **do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity, seek** a republican form of government, protection against foreign invasion and domestic violence guaranteed by Article 4, Section 4 of the United States Constitution, and all privileges and immunities of citizens in the several states guaranteed by Article 4, Section 2 of the United States Constitution, **ordain and establish** New California as a fully vested State of the Union of States in the United States of America.*

First Amendment of the United States Constitution states:

Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances.

Therefore the Counties of New California bring forward 40 Grievances against the government of California to be announced in public on Tuesday at 11:00 am each week for 40 weeks.

Statement of Facts

The people of California are suffering from a tyrannical communist state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America. All caused by a government of and for a mono party system lead by a tyrannical dictator.

Declaration of Grievance

United States Constitution Article VI Section 2 States:

"This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding."

The government of California, the current governor and mono party system along with local officials are following a coordinated design with the intent to actively engage in **acts of insurrection** against the U.S. Constitution.

EXISTENTIAL THREAT TO THE TERRITORIAL INTEGRITY OF THE UNITED STATES OF AMERICA

The citizens of California owe their primary allegiance to the United States of America, and daily are put at risk of their safety, happiness, security, and livelihood by the damage the rogue government of California has perpetrated on the territorial integrity of the California border, which is also the United States border. This crime also threatens to disaffect us from our common bond to the other states in the union.

EXISTENTIAL THREAT TO THE UNITED STATES CITIZENSHIP OF CALIFORNIA CITIZENS

By intending and conspiring to secede from the United States of America, the rogue governor and his associates have created an existential threat to the citizenship status of those United States citizens living in California, putting the birthright and posterity of Californians with loyalty to the United States of America at risk and peril. The citizens of New California consider United States citizenship something worthy of defending, not only on our own behalf, but that of our posterity and our fellow citizens in the United States. We, the citizens of New California, do consider our status as United States citizens to be in jeopardy and at peril due to the tyrannical government that is imposing its constitutionally non-judicial power of us in violation of U.S. Constitution Article VI Section 2.

NO-GO ZONES WITHIN THE STATE OF CALIFORNIA

The refusal and failure of the rogue and revolutionary government of California to enforce law and its intervention in law enforcement is not only a breach of the separation of powers, but has created “no-go” zones where those considered to be undesirable minorities are not able to pass safely without fear of physical harm. This now constitutes a reign of terror. On a daily basis, citizens of this state are intimidated, threatened, and even physically harmed for political reasons. This behavior is sanctioned by the rogue government of California by both acts of commission and acts of omission, and its occurrence is most frequent in those cities known to be “sanctuary cities” and places with “urban values” that are defended by the rogue government of California to the detriment of those who do not adhere to the mono party values in violation of U.S. Constitution Article VI Section 2.

PURPOSE OF EVASION

Public officials, sworn in by oath of allegiance to the highest offices in the State of California have purposely evaded mandatory provisions in United States law and in California law and by disingenuous swearing of such oath of office have, in a premeditated manner defrauded the citizens of this state with intent to displace the normal operation of the legal system guaranteed by our Constitution and have betrayed their oaths of office with purpose of evasion. This has not been a light or transient grievance in this state, and has created a condition whereby the remedy of *separation and formation of a new state can be the only peaceful remedy.*

STATE-SPONSORED TERRORISM

The rogue tyrannical and secessionist government of California, existing in a state of rebellion and insurrection, as referred to in the United States Constitution has become a state sponsor of terror in its support of communist revolutionaries that it has facilitated to operate with impunity and even with protection by the organs of the state, and foreign nationals that it encourages and facilitates to enter the country illegally, and has become complicit in murder, vandalism, theft, rape, and outrageous crimes. The citizens of New California do invoke the constitutional right to right to self-defense and defense of our communities.

The current governor is guilty of California's incessant violations of federal law that *have caused grievous crimes* to be committed against it's own citizens.

Illegal Acts and Tactics

Utilizing *Marxist-Leninist* and *Maoist revolutionary tactics* the communist California governor, mono party system and local government officials support and celebrate these tactics as a means to introduce and subvert all aspects of California government and civil society in an attempt to destroy the State of California and breakdown the sovereignty of the Union of the United States of America.

Acts of Secession

Therefore the California communist government in conjunction with the communist state executive, instituted wherever the current communist governor has usurped power has created a reign of terror on United States Citizens living in California with the intent to **secede** from the United States of America and thus destroy the very **Union of States** which secures our **Liberty and Freedom**.
