# Grievance 35

September 18, 2018

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

## Article IV Section 3 United States Constitution states:

*New States may be admitted by the Congress into this Union; but no new States shall be formed or erected within the [Jurisdiction](#) of any other State; nor any State be formed by the Junction of two or more States, or parts of States, without the Consent of the Legislatures of the States concerned as well as of the Congress.*

## Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

*“We are determined to live under a State Government in the United States of America and under the Constitution of the United States”.*

# **New California Declaration of Independence of**

**January 15, 2018 states:**

*“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.*

*When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security.*

*So it is the history of the past and present Governor and Government of California who have a history of repeated injuries and usurpations, all having in direct Object the establishment of a Tyranny over the Counties of New California and the State of California.*

*Whenever any Form of Government becomes destructive of these ends, it is the Right of the People to seek a constitutional remedy to the abuse of powers”.*

## **Preamble of the New California State Constitution states:**

*We, the representatives of the undersigned Counties within the State of California, **do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity, seek** a republican form of government, protection against foreign invasion and domestic violence guaranteed by Article 4, Section 4 of the United States Constitution, and all privileges and immunities of citizens in the several states guaranteed by Article 4, Section 2 of the United States Constitution, **ordain and establish** New California as a fully vested State of the Union of States in the United States of America.*

## **First Amendment of the United States Constitution states:**

***Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances.***

Therefore the Counties of New California bring forward 40 Grievances against the government of California to be announced in public on Tuesday at 11:00 am each week for 40 weeks.

## Statement of Facts

The people of California are suffering from a tyrannical communist state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America. All caused by a government of and for a mono party system lead by a tyrannical dictator.

## Declaration of Grievance

United States Constitution Article VI Section 2 States:

***"This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding."***

The communist California government and the current *communist* governor have fostered, supported, legislated, enacted and enforced unconstitutional laws and regulations in direct violation of Article VI Section 2 known as the "Supremacy Clause".

### **REDUNDANT BUREAUCRACY:**

### **STATE-SPONSORED TERRORISM:**

The rogue tyrannical and secessionist government of California, existing in a state of rebellion and insurrection, as referred to in the U.S. Constitution has become a state sponsor of terror in its support of communist revolutionaries. Facilitated by the state government of California they operate with impunity and even with protection by the organs of the state. Illegal foreign nationals are encouraged and facilitated to enter the country illegally, and have become complicit in murder, vandalism, theft, rape, and outrageous crimes. The United States Citizens of New California do invoke their Constitutional right to redress of grievances as well as their right to self-defense and defense of our communities.

### **CRIMINAL JUSTICE SYSTEM NEGLECT OF VICTIMS:**

The present criminal justice system is energized by the moneyed interests associated with collectivized labor as well as private businesses which profit from incarceration. Amidst these interests, justice and restitution to the victims of crime is neglected in favor of incarceration.

The communist California government and the current *communist* governor are enabling and perpetuating a *war zone* across the northern border of Mexico and southern border of California.
