# State of New California **NOTICE** <u>TO ALL CALIFORNIANS!</u> <u>Chapter II</u> **Grievance 29**

**NOVEMBER 10, 2020** 

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

#### **Statement of Intent**

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

*"We are determined to live under a State Government in the United States of America and under the Constitution of the United States."* 

## New California Declaration of Independence of January 15, 2018 states:

"Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

When a long train of abuses and acts to seize and hold the people's power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their **Right, it is their Duty**, to throw off such Government, and to provide new Guards for their future security.

#### Preamble of the New California State Constitution states:

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

#### First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Fourth Amendment of the United States Constitution states:

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

The Counties of New California State brought forward 95 Chapter I Grievances between January 2018 and November 2019. On April 28, 2020 New California State will issue 95 additional Chapter II Grievances to be announced in public on Tuesdays at 11:00 am.

# Grievance 29

#### **Declaration of Grievance Statement of Facts**

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

#### California State Government Violates the Following: United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

#### **United States Constitution Article VI**

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

#### **First Amendment, United States Constitution**

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

#### Fourteenth Amendment, United States Constitution

<u>Section 1</u>. All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.

<u>Section 3</u>. No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.

# ORDER OF THE DAY INSURRECTION

*We*, the People, of the Unified Counties of New California seek the removal of the California state GOVERNOR. *We* are determined to stop the "one man rule" of a *pusillanimous* craven dictator whose words and actions are a grave danger to all U.S. Citizens living in California.

Following last week's general election *We*, the People, of the Unified Counties of New California now have the answers as to why elections in California are always massively in favor of the mono party and the craven dictator governor.

Here's the formula; massive vote by mail, vote harvesting, illegal gerrymandering (involving foreign countries), the assistance of United States National Security agencies bad actors, a company known as Dominion owned by two California politicians which uses an election hardware / software that manipulates elections in foreign countries all financed by foreign governments and politically targeting by social media by Big Tech. This is the California formula that has been stripping Californians of their God Given Constitutional Rights since 1996. Now this formula has spread to the rest of the United States and is stripping ALL United States Citizens of their God Given Rights.

Now President Donald J. Trump must invoke the Fourteenth Amendment the *Insurrection Act* of 1807 and the Emergency Economic Powers Act to strip Electoral College votes from states engaged in an illegal INSURRECTION against our republic.

#### On November 05, 2020 <u>Mike Adams</u> from Natural News wrote:

"Two months ago, I detailed Trump's powers under the Fourteenth Amendment, which grants the President the power to declare an illegal insurrection against the United States of America and strip Electoral College votes from states which are engaged in a coordinated insurrection.

The blatant, brazen vote stuffing fraud now taking place in Wisconsin, Michigan, Pennsylvania and other states reveals **a pattern of criminal insurrection taking place** via organized vote fraud. This is a form of criminal insurrection against the United States of America.

The Fourteenth Amendment speaks directly to the powers of the federal government in dealing with officials, individuals and states that are engaged in "rebellion" against the United States of America.

Specifically, the Fourteenth Amendment grants the U.S. President the power to:

• Arrest and indefinitely hold all public officials — including mayors, governors, state legislators, *federal judges* and law enforcement officials — who support

"rebellion" against the United States or who have "given aid or comfort" to the enemies of America. (Section 3)

- Eliminate House of Representatives positions for California and other states which are engaged in supporting Big Tech censorship platforms that are supporting rebellion against the United States of America and "abridging" the right of voting-aged citizens to participate in elections (via censorship). This implies that Electoral College votes would also be proportionally reduced in these states. (Section 2) It would also apply to states like Oregon which are <u>reportedly funding</u> "war <u>encampment</u>" installations that house insurrectionists who are unleashed each night to attack federal buildings and federal law enforcement officers.
- Eliminate all federal financial support for cities and states which are engaged in "insurrection or rebellion" against the United States. Section 3 specifically states that all such claims of federal money obligations to the states "shall be held illegal and void." (Section 4)

In essence, the Fourteenth Amendment grants American citizens "equal protection" under law, but for public officials or states which are engaged in "insurrection or rebellion" against the United States, those equal protections are **revoked**.

The Democrats already know all this, which is why they are pursuing a plan of election chaos, hoping to throw the entire election process into mass confusion, from which they plan to attempt an illegal coup to eliminate Trump from office and claim political power over the nation".

What the Fourteenth Amendment clearly says is that when states are engaged in open rebellion against the Constitution and the United States of America, they can be declared to be "insurrectionist" states and blocked from having their Electoral College votes count.

The president's power to declare this insurrection and remove states from the Electoral College system is directly described in the Fourteenth Amendment, Sect. 2:

[W] hen the right to vote at any election for the choice of electors for President and Vice-President of the United States, Representatives in Congress, the Executive and Judicial officers of a State, or the members of the Legislature thereof, is denied to any of the male inhabitants of such State, being twenty-one years of age, and citizens of the United States, or in any way abridged, except for participation in rebellion, or other crime, **the basis of representation therein shall be reduced** in the proportion which the number of such male citizens shall bear to the whole number of male citizens twenty-one years of age in such State.

In other words, by committing ballot fraud and supporting nationwide censorship via Big Tech, states like California, Wisconsin, Michigan, New York, Illinois and others have "abridged" the right of people to vote. Voting in a fair and free election requires access to fair and free information, and that's exactly what Big Tech censorship has denied the American people.

Furthermore, Section 3 of the Fourteenth Amendment allows the president to remove from public office any public official or member of Congress who has violated their sworn oath to protect and defend the U.S. Constitution. As stated in Sec. 3:

No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof".

So the corrupt California election system does its magic one more time and knowingly enables the outcome of the 2020 Presidential election through <u>voter fraud</u>. Working in harmony with ballot harvesting, vote by mail and the national security agencies of the United States government's deep state actors the California "system" provided a massive wall of voter fraud that derailed the 2020 Presidential Elections not just in California but the nation. California is protecting Big Tech's politically targeted censorship and utilizing the "California formula". <u>California's Electoral College</u> votes must be revoked.
