



## Legislative Background for Joint Resolution 19-

### **United States Constitution Article IV Section 4**

The U.S. Constitution of the United States of America is the supreme law of the land. Article VI, Section 4 of the United States Constitution guarantees to every state in the Union a republican form of government, and to protect each of them against invasion; and on application of the legislature, or the executive (when the legislature cannot be convened) against domestic violence.

### **United States Constitution Article VI Section 2**

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

**A JOINT RESOLUTION OF THE ASSEMBLY AND THE SENATE OF NEW CALIFORNIA  
STATE DECLARING THE STATE OF NEW CALIFORNIA SHALL HAVE NO SANCTUARY  
STATUS AS IT RELATES TO ILLEGAL IMMIGRATION**

**WHEREAS**, the United States Constitution, Article IV, Section 4 guarantees to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence;” and

**WHEREAS**, the United States Constitution, Article IV, Section 2 states “This constitution, and the laws of the United States which shall be made in pursuance thereof; and all treaties made, or which shall be made, under the authority of the United States shall be the supreme law of the land; and the judges in every state shall be bound thereby, any thing in the constitution or laws of any state to the contrary notwithstanding; and

**WHEREAS**, the government of California, the current socialist governor and mono-party system along with local officials are following a coordinated design with the intent to actively engage in **acts of insurrection** against the U.S. Constitution; and

**WHEREAS**, SB 54, officially presented as “The California Values Act” prevents essential contact between California law enforcement officers and Immigration and Customs Enforcement (ICE); and

**WHEREAS**, ICE issues detainers to local jails, and law enforcement officers release the names of released convicts before turning them over to ICE; and

**WHEREAS**, following revisions to SB 54, the socialist California governor and state law enforcement jurisdictions *may* report heinous crimes to ICE if they choose to; and

**WHEREAS**, despite passage of this law (California Values Act), ICE won’t end deportations; and

**WHEREAS**, California citizens from sanctuary cities and counties want their local police to cooperate with ICE and deport illegals; and

**WHEREAS**, California citizens are prevented from speaking out due to the potential for retribution from local politicians and corrupt special interests running these cities; and

**WHEREAS**, most of illegals settle in urban areas and live off the taxpayer; and

**WHEREAS**, Senator Dianne Feinstein opposed Kate’s Law (named after sanctuary city victim Kate Steinle of San Francisco); and

**WHEREAS**, Kamala Harris advocates for DACA recipients and illegal alien families; and

**WHEREAS**, most of the crimes in Texas, California, and Arizona are federal crimes, connected to illegal aliens; and

**WHEREAS**, the economic war against working-class Americans wages and quality of life is evidence that illegal aliens present far more harm than any good; and

**WHEREAS**, New California State Citizens oppose the Sacramento political class’ militant scheme to diminish citizenship and undermine our sovereignty as United States Citizens; and

**WHEREAS**, socialist mono-party candidates advertised their intent to make our streets less safe when they run for election; and

**WHEREAS**, with both the executive and the legislative branches controlled by a socialist mono-party there exists a dictatorship in California; and

**WHEREAS**, because of the socialist mono-party candidates’ hatred of President Trump, SB 54 “The California Values Act” was passed; and

**WHEREAS**, for nine months activists from San Diego to the Bay Area petitioned locally elected officials to signal their opposition to SB 54; and

**WHEREAS**, law enforcement agencies and unions opposed SB 54 “The California Values Act,” regardless of amendments; and

**WHEREAS**, ICE must go directly into neighborhoods, schools, and workplaces to apprehend illegal aliens because SB 54 “The California Values Act”, disallows ICE from entering prisons; and

**WHEREAS**, Governor Jerry Brown’s decision to sign SB 54 “The California Values Act” and make California a sanctuary state for illegal aliens – including those who have committed crimes – undermines public safety and hinders ICE from performing its federally mandated mission; and

**WHEREAS**, SB 54 “The California Values Act” allows dangerous, violent, career criminals to slip through the cracks and be released back into our communities; and

**WHEREAS**, SB 54 “The California Values Act” creates sanctuary for criminals who are preying on our communities; and

**WHEREAS**, SB 54 “The California Values Act” does not draw a distinction between criminals or innocents; and

**WHEREAS**, SB 54 “The California Values Act” puts all United States citizens who live in New California State at risk; and

**WHEREAS**, under SB 54 “The California Values Act” Sheriffs warn that the working families in the undocumented community are particularly vulnerable and ICE will have no option other than to do sweeps in order to catch the criminal illegal aliens and that non-criminal illegal aliens will get caught up in the sweeps;; and

**WHEREAS**, SB 54 “The California Values Act” protects the predatory criminal illegal aliens who prey on the children, elderly and women in the undocumented community; and

**WHEREAS**, SB 54 “The California Values Act” prohibits state and local law enforcement agencies from using any of their resources to investigate, interrogate, detain, detect, or arrest persons for immigration enforcement purposes; and

**WHEREAS**, SB 54 “The California Values Act” specifically prohibits cooperation and communication with federal immigration authorities, unless the federal government first issues a federal warrant, which is not always feasible; and

**WHEREAS**, a University of California, Berkeley study of more than 1,000 Californians, “Voters Don’t Want Sanctuary Cities; Politicians Do” found 74 percent oppose sanctuary city policies; and

**WHEREAS**, SB 54 “The California Values Act” pushed by the socialist mono-party to restricts local police and sheriffs from assisting or cooperating with federal immigration authorities; and

**WHEREAS**, the UC Berkeley study results included 73 percent of Democrats and 65 percent of Hispanics; and

**WHEREAS**, there is broad-based opposition to the idea of sanctuary cities; and

**WHEREAS**, New Californians want their local officials to abide by the requests of federal authorities.; and

**WHEREAS**, the people of California are suffering from a tyrannical socialist state government which fails to provide a republican form of governance.

**BE IT RESOLVED** that we as the citizens of New California State, declare that the people of California are suffering from a tyrannical socialist state government which enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals.

**BE IT FURTHER RESOLVED** we as the citizens of New California State, declare that the people of California are suffering from a tyrannical socialist state government which protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a socialist government of and for a mono-party system lead by a tyrannical socialist dictator who openly defies federal law.

**BE IT FURTHER RESOLVED** we as the citizens of New California State, having observed the takeover and corruption of our once proud republic, give a clarion warning to the other states of the union that the old California Republic has been the experimental laboratory for what the enemies of liberty seek to export to other states for the destruction of the republican forms of government they hate.

**BE IT FURTHER RESOLVED** we as the citizens of New California State, declare that the state of California rights denounce in the strongest terms SB 54 known as the "The California Values Act".

**BE IT FURTHER RESOLVED** the government of California, the current socialist governor and mono-party system along with local officials are following a coordinated design with the intent to actively engage in acts of insurrection against the U.S. Constitution.

**BE IT FURTHER RESOLVED** the Insurrection Act of 1807 is a United States federal law that governs the ability of the President of the United States to deploy military troops within the United States to put down lawlessness insurrection, and rebellion.

**BE IT FURTHER RESOLVED** we as the citizens of New California State, declare that the California government in conjunction with the socialist state executive, instituted wherever the current socialist governor has usurped power has created a reign of terror on United States Citizens living in California with the intent to secede from the United States of America and thus destroy the very Union of States which secures our Liberty and Freedom.

**BE IT FURTHER RESOLVED** we as the citizens of New California State, declare the betrayal by the sitting socialist governor of California the mono-party legislature and local elected officials is evidence of abdication of their responsibilities of authority and sovereignty over the State and Citizens of the United States living in California.
