Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

"We are determined to live under a State Government in the United States of America and under the Constitution of the United States."

New California Declaration of Independence of January 15, 2018 states:

"Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

*When a long train of abuses and acts to seize and hold the people's power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their **Right**, it is their **Duty**, to throw off such Government, and to provide new Guards for their future security.*

*The history of the present Governor and Government of California is a history of repeated injuries and usurpations, all having in direct object the establishment of a **Tyranny** over the Counties of New California and the State of California.*

Preamble of the New California State Constitution states:

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Fourth Amendment of the United States Constitution states:

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

DECLARATION OF CONSTITUTIONAL DEFAULT

A REPUBLIC

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical pusillanimous dictator who openly defies federal law.

CALIFORNIA STATE VIOLATES:

United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

United States Constitution Article VI

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

First Amendment, United States Constitution

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Fourteenth Amendment, United States Constitution

Section 3. *No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.*

A REPUBLIC

The State of California is in constitutional default and does not have constitutional standing as a member state in the union of states called the United States of America.

There is NO lawful Government by the standards of the 1849 California State Constitution in California.

We the People as citizens of the United States living in California are following the process of West Virginia, which successfully restored the Virginia state government after the Wheeling Conventions of 1861. Congress admitted California into the Compact of Statehood within the United States of America in 1850 because their 1849 Constitution, ratified for consideration, guaranteed a *republican* form of government.

United States Constitution Article IV, Section 4.

Protection of States Guaranteed Republican Form of Government

"The United States shall guarantee to every state in this union a republican form of government...."

The California Constitutional Convention of 1878-79

"In 1877 and 1878 California was suffering from 'shard times'. This was aggravated by the collapse in mining stocks, which from a value of three hundred million dollars in 1875 had fallen to thirty million dollars in 1878. The hard times "prepared the public mind to accept any change which promised the recovery of the state from the depression into which business had been thrown."

In 1879 many who were "socialistic and communistic in their ideas" assembled in Sacramento and wrote a new "constitution" to replace the original 1849 Constitution that had been approved by congress for statehood that was "republican" in form of government. In 1879 California adapted the corporate "constitution". Corporations are not Constitutional Governments and do not have legal lawful authority over a "Compact" Constitution authorized by the United States Government.

**"CONSTITUTION OF THE STATE OF CALIFORNIA, 1879
As Last Amended November 8, 2016"**

"FOREWORD The California Legislature is privileged to present this compilation of historic documents. Taken together, these compacts, treaties, and charters embody the ongoing evolution of our core principles of representative democracy. It is important to note that our state Constitution is a living document. It has been amended over 500 times since its adoption in 1879. Some recent amendments have included a change to California's Term Limits law through the passage of Proposition 28 (2012), the California Legislature Transparency Act enacted by Proposition 54 (2016) enhances public access to the legislative process, and with the adoption of Proposition 25 (2010), the vote threshold to pass the state budget is now a majority vote. One hundred and sixty-eight years since its inception, the Golden State continues to be a leader throughout the nation and the world. Innovative public policy is often crafted, analyzed, and debated by the Legislature with the collective input of the electorate. This sense of progress and purpose can also be found in the documents featured in this publication, as our nation and state continue to strive for a more perfect union. The framers of our Constitution envisioned a democracy that protected fundamental "freedoms" and "rights." Over time, these freedoms and rights have evolved to embrace a more diverse and inclusive society. Our state Constitution provides such a framework. It is in that spirit of freedom the California Legislature presents these important documents, which shape our collective philosophy and the vision for a government of the people. 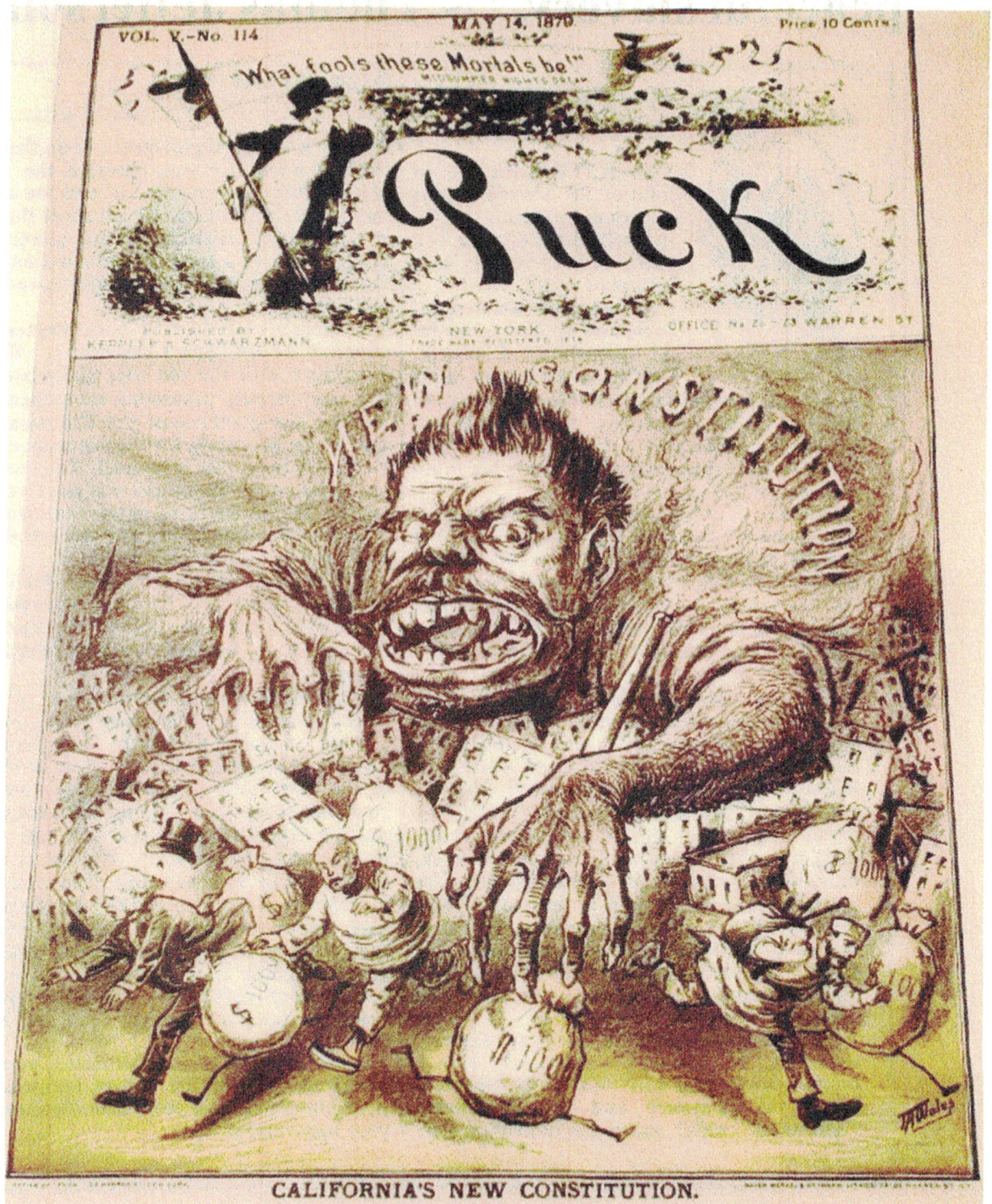

CALIFORNIA is the spoiled child of the United States; and what California needs, and will ultimately get, is a good, sound, square, old-fashioned spank.

Reversed over the national knee, and squirming under the governmental slipper, California may have some of her superfluous boundlessness shaken out of her, and a little solid ballast of horse-sense and self-respect hammered into the region which she now uses, apparently, to perform her intellectual and logical functions.

Not that California has not brains enough—the trouble is simply that she has not yet learned how to use them. Practically the baby of the family, born with a golden spoon in her mouth, she has traded on her congenital charms and capabilities until the precocity which was once our pride has become a nuisance and an absurdity.

The two extreme ends of this country are decidedly objectionable, each in its own way. New England is priggish and California is *boundless*. But the affectations of culchahed Massachusetts are merely superficial: they do not militate against the existence of a healthy moral and mental equilibrium which asserts itself whenever the nation gets a serious shock, whether from external or internal causes. We laughed at the long-haired enthusiasts of Boston who whined and slobbered over the Slave; but we looked with perfect confidence to the Men of Concord, when the time came to *fight* for that mahogany unfortunate: and they were there.

But California! Ah! if her boundlessness were only as innocent a folly. It is not. Boundlessness does not mean only the ostentation, the arrogance and the opinionated "smartness" which make the individual Cali-

fornian a social nightmare. Boundlessness is the only word that can describe the chaotic ideas of the western agitator, and the colossal impudence with which he advances them. It is "freshness" raised to the *nth* power. It is crude brain in a state of fermentation. And the matters thence evolved are characteristic and—cussed.
