### Who Are We?

- New California State will be the 51<sup>st</sup> state formed from rural old State of California.
- California rises from LA, Bay Area and Sacramento urban areas and receives a new Constitution.
- A 501©4 state splitter to maintain the Compact of the Union of States NOT SECESSIONIST.

### How Can This Be Done?

- Article IV, Section 3 of The United States Constitution, allows for a new state to be formed from an existing state with the approval of the State Legislature and Congress. This was done in 1860 when West Virginia split from Virginia by creating a restored VA gov after VA seceded.
- Article IV, Section 4 of The United States Constitution, The United States shall guarantee every state in the Union a Republican Form of Government and shall protect each of them against invasion and domestic violence. ### Many Have Failed This Attempt!

- EXACTLY—This is the first time in over 200+ attempts to form a new state from California where the Constitutional Blueprint of Article IV, Section 3 is being followed.
- New California State achieved “Standing” in the U.S. Supreme Court based on its declared independence, 190 grievances, 16 declarations of truths, 15 CA default notices, 15 proclamations, 13 Const. Conventions, CA official’s lawsuits, 7 Const. Conventions. for Reorganized/Restored CA and 3 Ordinances for CA’s slavery, Insurrection Against the Constitution and Secession.

## NEW CALIFORNIA STATE LAUNCHED



### State

- Enjoys “Fresh Start” accounting with a **NEW** Constitution and an 88% vote to change.
- New California will NOT be a sanctuary state.

## WHY CALIFORNIA CANNOT BE “SAVED”



- California violates Article IV, Section 4: no republican form of government, freedom from invasion or freedom from domestic violence.
- California is in violation of the Compact of the Union of States for financial audit failures.
- Estimates point to 150 years minimum litigation to untangle California’s legal messes.
- Only 6% of the budget is subject to manipulation—all else sealed in with the fake contract replaced California Constitution in 1879 by the progressives/communists.
- Unaudited financials going back seven years prohibit borrowing or bond issuance due to credit rating damage, thereby admitting the financial abuse and disaster.

## CALIFORNIA STATE REORGANIZED NOW RESTORED

- Leaves 1879 Corporate Const, returns to the original 1849 Const. with an 88% vote to change.
- Financials will have been forensically audited.
- New California increases CA cash flow day one by 15-20 billion dollars. This results in better cashflow accounting based on their expenses.

## NCS ACCOMPLISHMENTS



- 200+ attempts have been made to separate CA — New California State (NCS) is first to follow the U.S. Constitution VA/W VA model. A state split has not been done since 1861.
- New California follows Article IV, Sections 3 & 4.
- Conducted more than 800 Public Conference Calls. (You have used a couple numbers lately)
- Declared Independence from California January 15, 2018.
- Wrote a constitution that is republican in its form.
- 40 ROV/clerk recorders gone from declarations and affidavits.
- Educated sheriffs on the lesser magistrate and their constitutional powers if elected.
- Shasta, Riverside, San Luis, etc. had election lawsuits prior to outside involvement.
- Delivered 190 grievances, 16 declarations of truth, 15 notices of default, 15 proclamations read in public squares across California & 3 ordinances.
- 76 field hearings for the public.
- A working Legislature in NCS with a Bicameral Senate and Assembly.
- 58 county committees formed expressly for the purpose of creating the State of New California.
- Accelerates statehood with CA existential financial threat.
- The Reorganized Government of CA held 7 Constitutional Conventions with the 5th creating Restored California and declared it will remain in the U.S. & controls CA's 1849 Compact Const.
- Statehood documents are in the House of Representatives with the Speaker of the House.
- Conducted one Demo and four Elections on New California State's Constitution in a one-day, in person, with proof of ID and residency, on paper ballots, no machines, clear box method, same day results, at small local precincts, etc.
- New California State follows the U.S. Constitution to the letter.

### **NCS held 13 Constitutional Conventions:**

Following the January 15, 2018, New California State Declaration of Independence: 1st Const Conv at Harris Ranch July 21, 2018, 2nd Const Conv in Irvine October 5-6, the 3rd Const Conv in Roseville, January 26, 2019, the 4th Const Conv in Fresno, 5th Const Conv in Irvine, October 25-26, 2019, 6th Const Conv in San Luis Obispo, 7<sup>th</sup> Const Conv in Fresno, 8<sup>th</sup> Const Conv in San Luis Obispo; 9<sup>th</sup> Const Conv in Virtual, 10<sup>th</sup> Const Conv in Anaheim, 11<sup>th</sup> Const Conv in Roseville, 12<sup>th</sup> Const Conv in Irvine, 13<sup>th</sup> Const Conv in Visalia.

### **Lawsuits:**

- Filed two Lawsuits Against Gavin Newsom, Alex Padilla and Shirley Weber. The ballots in CA 2020 were missing the statutory election code for the selection of Delegates. New California filed the lawsuit and sent a letter to Pence notifying him of the faulty ballots that by law should not have been cast or counted. The courts delayed and Pence accepted the CA delegation. New California also filed notification with the Registrars throughout the state and both SOS Padilla and Weber were served—they did nothing about it either.
- New California also filed with Chris Bish to challenge Doris Matsui and Adam Schiff living outside their Congressional Districts.
- New California submitted a Delegation of 55 members to represent California's delegation because none had been selected.
- New California joined the Texas lawsuit as an Amicus brief to challenge the changes to election code by states. This was not authorized by the legislature. California legislators Kiley & Gallagher challenged the Newsom executive order for all mail-in ballots and won. The judgement announcement arrived the day before the general election began. The amicus brief was accepted! First new state movement recognized in history with an accepted Amicus brief.
- Filed four Amicus Briefs with the U.S. Supreme Court in Support of President Trump.
- Amicus with Brunson case under review with Supreme Court—plus, plus, plus...!
