# State of New California NOTICE TO ALL CALIFORNIANS! Chapter II Grievance 56

May 18, 2021

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

#### **Statement of Intent**

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

"We are determined to live under a State Government in the United States of America and under the Constitution of the United States."

### New California Declaration of Independence of January 15, 2018 states:

"Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

When a long train of abuses and acts to seize and hold the people's power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their **Right, it is their Duty**, to throw off such Government, and to provide new Guards for their future security.

#### **Preamble of the New California State Constitution states:**

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

#### First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

#### **Fourth Amendment of the United States Constitution states:**

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

The Counties of New California State brought forward 95 Chapter I Grievances between January 2018 and November 2019. On April 28, 2020 New California State will issue 95 additional Chapter II Grievances to be announced in public on Tuesdays at 11:00 am.

## Grievance 56

#### **Declaration of Grievance Statement of Facts**

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

#### California State Government Violates the Following: United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

#### **United States Constitution Article VI**

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

#### First Amendment, United States Constitution

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

#### Fourteenth Amendment, United States Constitution

<u>Section 3</u>. No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.

# ORDER OF THE DAY RECALLS

On Monday, <u>President Joe Biden spoke</u> on the issue of vaccines to the American public, including what appeared to be a veiled threat that people not getting the vaccine will "pay the price" for not getting it.

"If the unvaccinated get vaccinated, they will protect themselves and other unvaccinated people around them. If they do not, states with low vaccination rates may see those [COVID-19 infection] rates go up, may see this progress reversed."

"Only those who are not vaccinated will end up paying the price. The vaccinated will continue to be protected against".

Last week the Orange County supervisors voted to 'pause' a vaccine passport plan as over 1500 hundred protesters showed up outside the meeting and *more than 700 OC residents signed up to speak at the board meeting.* 

#### Cal Globe reported:

<u>"Dr. Clayton Chau,</u> director of the Orange County Health Care Agency and acting county health officer recently proposed a pilot program for "vaccine passports" in the county – a "show-me-your-papers" or "digital passport" program to provide COVID vaccination evidence, the Globe <u>reported</u>".

"Orange County residents were so outraged, hundreds protested outside the Orange County Board of Supervisors meeting, and more than 700 signed up to speak in opposition to the proposed vaccine passport".

From business owners to lawyers to everyday residents, the list of speakers went on for hours, ABC 7 <u>reported</u>.

"Being that I am a Black American, and you're asking me now to carry 'freedom papers' is absolutely appalling. I will bring every Black member of this community back down here if this goes any further," said a speaker," ABC 7 reported.

Another speaker was just as direct: "This isn't communist Russia, this isn't communist China, this isn't Nazi Germany. We should have the freedom. The Jews had passports, look what that led to."

Four of the five supervisors voted to "pause" the proposal, but one remained supportive of the vaccine passport program, as ABC 7 reported:

Katrina Foley is the one supervisor who stands firm in favor of a vaccine passport. She believes most people support it and that only a small faction of people are against it.

"These individuals are mostly people who don't believe in vaccinating in the first place. They're also people who in the past year have denied that COVID exists, denied the pandemic, have marched on our United States Capitol, participated in the insurrection," said Foley".

As attorney and author JD Vance recently <u>explained</u>, "what these passports threaten to do is devolve into a <u>Chinese-style</u> social credit system, enforced by our corporate overlords. Orange County residents should question why their public health director <u>Dr. Clayton Chau</u> proposed vaccine passports in the first place.

"Once you build the architecture for this kind of enforcement regime, it's easy to use it to reward 'good' behaviors or penalize 'bad' ones, Vance said.

All for an experimental vaccine for a virus that is 99.98% recoverable.

Article II of the California Constitution, approved by California voters in 1911, allows people to recall and remove elected officials and justices of the State Supreme Court from office.

ARTICLE II VOTING, INITIATIVE AND REFERENDUM, AND RECALL [SECTION 1 - SEC. 20] <u>SECTION 1.</u> All political power is inherent in the people. Government is instituted for their protection, security, and benefit, and they have the right to alter or reform it when the public good may require.

From the California State "Recall Procedures Guide as provided by the Secretary of States Office:

"Recall is the power of the voters to remove elected officials before their terms expire. It has been a fundamental part of our governmental system since 1911 and has been used by voters to express their dissatisfaction with their elected representatives".

The citizens of New California will not comply with a covid-passport or any restriction on our God Given Rights given as an unlawful edict issued by a craven dictator or as a group of craven county supervisors, health officials or any state or federal officials...

Recalls are now in order: What every American citizens has is a "Right to Redress of Grievances" as provided in the 1<sup>st</sup> Amendment of the U.S. Constitution.
