TO ALL CALIFORNIANS! **CONSTITUTIONAL DEFAULT**

APRIL 10, 2022

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

United States Declaration of Independence of July 4, 1776 States:

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness. --That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, -- *That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness.* Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. *But when a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their Right, it is their Duty, to throw off such Government, and to provide new Guards for their future security.*--Such has been the patient sufferance of these Colonies; and such is now the necessity which constrains them to alter their former Systems of Government. The history of the present King of Great Britain is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over these States.

Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

State of New California Affirmation of Allegiance to the United States of America January 15, 2018 states:

“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”

State of New California Declaration of Independence January 15, 2018 states:

“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

*When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their **Right**, it is **their Duty**, to throw off such Government, and to provide new Guards for their future security.*

Preamble of the State of New California Constitution states:

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

First Amendment of the United States Constitution states:

“Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances.”

Fourth Amendment of the United States Constitution states:

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

THE PATRIOT STATE

New California State is a new state in development forming from the State of California. New California State is exercising its God Given Rights as declared in the 1776 United States Declaration of Independence and as ratified in the 1789 United States Constitution under Article IV Sections 3 & 4.

State of New California Statement of Facts

CALIFORNIA STATE VIOLATES:

United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

United States Constitution Article VI

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

First Amendment, United States Constitution

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Fourteenth Amendment, United States Constitution

Section 3. No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.

The Provinces of Alta California were officially dissolved by a statehood *compact* made between the Congress of the United States of America and the *People of California* on November 9, 1850.

State of New California and the State of California are not provinces of any nation or world power or religion.

However it is clear by the actions of the State of California government that old provincial ties have been reestablished, renewed, expanded and have direct command and control over all government officials state and local to such a degree as to have turned the State of California into a tyrannical dictatorship.

A provincial administrative state *now* exists in California in direct violation of the November 9, 1850 *compact* with the United States of America.

We the Citizens of the State of New California have Petitioned for Redress of Grievances in the most humble terms. Reading a total of one hundred ninety Grievances at County Courthouse locations within the borders of New California State during the course of four years.

Nor have *We the Citizens of the State of New California* been wanting in attentions to our California brethren but our repeated Petitions have been answered only by repeated injury.

A Governor, whose character is thus marked by every act which may define a tyrant, is unfit to be the elected Governor of a free people. Likewise, *Elected, Appointed and Regional Officials* of the State of California whose character is thus marked by every act which may define a tyrant, are unfit to be the Elected, Appointed and Regional Officials of a free people.

Governors and Officials of the State of California have exhibited Evidence of Tyranny and Treason against the Citizens, Counties, Towns and Cities of the State of California:

The history of the present Governor of California, the past Globalist Governor of California and other Officials of the State of California is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over the State of California.

Today California is in a state of free fall at all levels. This free fall has been orchestrated over the last 170 years by socialist and communist and we're now nearing the end of their socialist/communist plan that clearly demonstrates a design to reduce United States Citizens living in California under absolute Despotism. All their plans have been in direct violation of both Article IV, Section 4 and Article VI of the United States Constitution.

Let it be know to all the world New California State and the State of California are not the properties, not the administrative state, not the province of any theocratic ruler, nor any monarch, nor foreign entity or government but are *States* in the United States of America.

New Californians and Californians stand united to follow the United States Constitution Article IV, Sections 3 and 4 to throw off the tyranny that has been foisted upon all Citizens of the United States.

CALIFORNIA STATE DECLARED IN CONSTITUTIONAL
DEFAULT BY EXECUTIVE DECREE

DECEMBER 1, 2021

NOTICE OF DEFAULT

California State is in Default and does not have United States Constitutional Standing as a member State in the Union of States called the United States of America.

California is in Default of the United States Constitution

Article IV, Sections 1 & 4.

Section 1

Full Faith and Credit shall be given in each State to the public Acts, Records, and judicial Proceedings of every other State. And the Congress may by general Laws prescribe the Manner in which such Acts, Records and Proceedings shall be proved, and the Effect thereof.

Section 4

The United States shall guarantee to every State in this Union a Republican Form of Government, and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence.

California is in Default of the United States Constitution

Article VI, Sections 1, 2, 3

Section 1

All debts contracted and engagements entered into, before the adoption of this Constitution, shall be as valid against the United States under this Constitution, as under the Confederation.

Section 2

This Constitution, and the laws of the United States which shall be made in pursuance thereof; and all treaties made, or which shall be made, under the authority of the United States, shall be the supreme law of the land; and the judges in every state shall be bound thereby, anything in the Constitution or laws of any State to the contrary notwithstanding.

Section 3

The Senators and Representatives before mentioned, and the members of the several state legislatures, and all executive and judicial officers, both of the United States and of the several states, shall be bound by oath or affirmation, to support this Constitution; but no religious test shall ever be required as a qualification to any office or public trust under the United States.

CALIFORNIA STATE IS DECLARED IN DEFAULT OF THE U.S. CONSTITUTION

The State of California is no longer in good standing as a member of the Union of States known as the United States of America.

From the January 15, 2018 New California State Declaration of Independence
