# Great State of New California Proclamation

## **January 15, 2024**

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution while utilizing the model of statehood established by West Virginia in 1861-1863.

## **Statement of Intent**

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

"We are determined to live under a State Government in the United States of America and under the Constitution of the United States."

# New California Declaration of Independence of January 15, 2018 states:

"Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

When a long train of abuses and acts to seize and hold the people's power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their **Right**, it is their **Duty**, to throw off such Government, and to provide new Guards for their future security.

#### Preamble of the New California State Constitution

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

# Statement of Facts Whereas:

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

# Whereas:

# **United States Constitution Article IV Section 4**

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

#### Whereas:

## **United States Constitution Article VI**

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

#### First Amendment of the United States Constitution

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

#### Whereas:

The self-proclaimed, usurping dictator of the failed state of California is guilty of imposing a communistic form of martial law. Utilizing unelected bureaucrats as a quasi-legal regional (Soviet style) authority for the unconstitutional imposition of mandated lock downs and wearing of masks, in complete contravention to empirical scientific studies that have repeatedly proven that masks are ineffective at preventing viral infection.

## Whereas:

The Fourth Amendment of the United States Constitution states that "the right of the People to be secure in their persons, houses, papers and effects shall not be violated".

#### Whereas:

The United States citizens living under the dictator's whimsical dictates, subjecting MILLIONS to unhealthy conditions and conditions that are destructive to liberty and the livelihoods of the citizens, are suffering with a patience and tolerance that requires intervention and deliverance from the Congress and the Executive Branch of the United States Government. Such has been the patient sufferance of this state and those United States Citizens living in it, and SUCH NOW IS THE NECESSITY which compels them to seek independence and self-governance according to the provisions of the United States Constitution. Let these facts be submitted to all who will listen and to all who will hear.

#### Whereas:

New California State movement has for over 5 years has been utilizing Article IV, Section 3 to form a new state in direct defiance of the California dictator just like the Founding Fathers had planned. *New Californians will NOT comply*.

#### Whereas:

The California governor is a pusillanimous craven dictator whose words and actions are a grave danger to all U.S. Citizens living in California while the state continues to operate outside the authorities of the U.S. Constitution violating Articles IV, Section 4, Article VI, the First and Fourth Amendments.

#### Whereas:

For New Californian's its our *GOD* given "*Right it is our Duty*" to protect our Declaration of Independence, our Constitution and our Bill of Rights with all means necessary from a craven dictator.

California's governor in now at the point where his edicts are meaningless, ineffective and not being followed by the people. We The People will act immediately to remedy these abuses by the establishment of the Great New California State.

# Insurrection

The people of New California, by their delegates assembled, do seek ratification of an act of the **United States Congress** a new state, to be called the Great State of New California, be formed and erected out of all or part of the territory from, but not limited to, the following counties: Alameda (Rural), Alpine, Amador, Butte, Calaveras, Colusa, Contra Costa, Del Norte, El Dorado, Fresno, Glenn, Humboldt, Imperial, Inyo, Kern, Kings, Lassen, Lake, Los Angeles (Rural), Madera, Mariposa, Marin, Mendocino, Merced, Modoc, Mono, Monterey, Napa (Rural), Nevada, Orange, Placer, Plumas, Riverside, Sacramento (Rural), San Benito, San Bernardino, San Diego, San Joaquin, San Luis Obispo, Santa Barbara, Santa Clara (Rural), Santa Cruz (Rural), Shasta, Sierra, Siskiyou, Solano, Sonoma, Stanislaus, Sutter, Tehama, Trinity, Tulare, Tuolumne, Ventura, Yolo, and Yuba.

be it Further Resolved, We The People of the Great State of New California, by their delegates assembled, do seek ratification of an act to include the formation and erection of the State of New California, within the boundaries of the State of California, to include the aforementioned counties.

be it Further Resolved, the Great State of New California Declared Independence form the State of California on January 15, 2018 has formed a government that has 3 branches, is republican in its form, read over 190 Grievances over 190 weeks, issued 20 Declarations of Default and Truth, conducted over 70 legislative field hearings in the counties of New California State, had 12 Constitutional Conventions conducted over 520 "live streaming" Public Conference Calls and has established the "Reorganized Government of the California State.
