**Re: Rigging California State Elections**

Dear Mr. President,

I write this letter on behalf of all Californians and New Californians.

While the State of California remains in the Union, the Government is not Constitutional as approved in 1849 by Congress. This "breach" of the compact is in direct violation of Article IV, Section four and Article VI of the United States Constitution. California is now in non state status. "*
