



## Legislative Background for Joint Resolution 19-

The U.S. Constitution of the United States of America is the supreme law of the land. The U.S. Constitution. Second Amendment states "*A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.*"

**A JOINT RESOLUTION OF THE ASSEMBLY AND THE SENATE OF NEW CALIFORNIA  
STATE DECLARING THE STATE OF NEW CALIFORNIA IS A PRO-SECOND AMENDMENT  
STATE AND AFFIRMS THAT THE RIGHT TO KEEP AND BEAR ARMS AND CARRY  
FIREARMS, CONCEALED AND OPEN-CARRY, IS A PERSONAL RIGHT, AND SHALL  
NEVER BE INFRINGED OR BANNED BY ANY GOVERNMENT**

**WHEREAS**, the United States Citizens of New California do invoke their Constitutional right to keep and bear arms. All people are by nature free and independent, and have certain inalienable rights, among which are those of enjoying and defending life and liberty; acquiring, possessing, and protecting property; and pursuing and obtaining safety and happiness; and

**WHEREAS**, A well-armed people are necessary to the security of a free individual, state, and country, the right of the people to keep and bear arms shall not be infringed. Every citizen shall have the right to keep and bear arms in the lawful defense of self or the State; and

**WHEREAS**, the people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals, and protects vicious criminals who commit outrageous acts of violence upon the citizens of America; and

**WHEREAS**, these criminals are from the foreign drug cartels who use rural wilderness area to farm drugs without infringement by the colluding California government and attack citizens who live and recreate in the same wilderness areas; and

**WHEREAS**, the California state government, a mono-party system lead by a tyrannical dictator, continues to deny its citizens the protection and self-defense rights they are entitled to under the U.S. Constitution; and

**WHEREAS**, the rogue tyrannical and secessionist government of California, existing in a state of rebellion and insurrection, as referred to in the U.S. Constitution has become a state sponsor of terror in its support of communist revolutionaries. This rouge government of California has systematically removed all provisions in the California Constitution of its citizen rights to keep and bear arms, and believes these rights are granted only by the government, which is in conflict with the United States Constitution; and

**WHEREAS**, facilitated by the state government of California, tyrannical revolutionaries operate with impunity and even with protection by the organs of the state. Rouge street gangs rule in many urban centers while drug cartels run freely in rural areas, while the state government not only limits its citizens right to self-defense, but is enacting laws to punish our peace officers both elected and appointed who try to defend their citizens or themselves from violent attacks; and

**WHEREAS**, illegal foreign nationals are encouraged and facilitated to enter the country illegally, and have become complicit in murder, vandalism, theft, rape, and outrageous crimes. The state of California also provides welfare and financial assistance to foreign nationals without regard to the cost or harm it is doing to the citizens of this state, which involves not only drug trafficking but weapons violence by these same foreign nationals; and

**WHEREAS**, public officials, sworn by oath of allegiance to the highest offices in the State of California have purposely evaded mandatory provisions in United States and California law by disingenuously swearing such oath in a premeditated manner have defrauded the citizens of this state with intent to displace the normal operation of the legal system guaranteed by the United States Constitution, and have thus betrayed their oaths of office with purpose of evasion; and

**WHEREAS**, the tyrannical California government and the current tyrannical governor are enabling and perpetuating a war zone across the northern border of Mexico and southern border of California. California has forgotten that a resident is not necessarily a citizen and has merged these two terms as the same, which they are not; a resident is just someone living here while a United States citizen has rights defined in the constitutions; and

**WHEREAS**, the government of California, the current governor and mono-party system along with local officials are following a coordinated design with the intent to actively engage in acts of insurrection against the U.S. Constitution. Thereby denying its citizen their individual Bill of Rights as defined within the United States Constitution; and

**WHEREAS**, the tyrannical California government and the current tyrannical governor are enabling systematic infringement upon the constitutional right to keep and bear arms by limiting the type, manufacture, style of firearms, magazine capacity as designed for said firearm and or the amount of ammunition that a citizen may purchase or have in their possession, including time, place and manner of possession; and

**WHEREAS**, the tyrannical California government and the current tyrannical governor has failed to identify the root cause of violence in any shooting by addressing the individual, either as a criminal or mental patient. They instead attack the tool, the firearm, and not the person committing the act. The highest cause of deaths in the United States and California is Drugs and the second highest is automobile accidents, and most deaths are suicides which points directly to mental health not firearms as the true causes to these tragic events; and

**WHEREAS**, the tyrannical California government and the current tyrannical governor has failed society also by not treating hard core criminals who commit acts of capital offense to the sentence they were given by a trial court and a jury of their peers, thereby incentive them and others that there is no penitently to murdering others in California; and

**WHEREAS**, the tyrannical California government and the current tyrannical governor has again failed society because the government no longer confines those mental patient that are a danger to themselves and others and has chosen to let them be dealt with as outpatients and mingle among society where they may freely attack others and or commit suicide; and

**WHEREAS**, the California Republic now actively works against the principles of liberty through its departments, in its schools, and in arbitrary and capricious selective enforcement of laws; and

**WHEREAS**, this crime also threatens to disaffect us from our common bond to the other states in the union thereby creating an existential threat to the territorial integrity of the United States of America. Gun free zones are really killing zones while we should protect our schools by arming those teachers and or staff to defend their students with firearms that they are both comfortable with and are trained to use of in this special environment, as has been recommended as a successful deterrent to school shootings; and

**WHEREAS**, now, like the historical tyrannical governments of the world, the California Republic seeks to remove the right of its citizens to defend these principles both in speech and remove their right to keep and bear arms, directly opposing both the first and second amendments of the United States Constitution, and these same legislators enact laws that effects the rights of citizen while exempting themselves from these same laws; and

**WHEREAS**, the California Republic now is openly hostile to the idea of government of, by, and for the people, in its repeated attempts to disenfranchise citizens and destroy both the state and Federal Republic through foreign influence; and

**WHEREAS**, Amendment II of the United States Constitution states clearly that “A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.” We believe that Section two of the Amendment here clearly states that the rights of the citizen to keep and bear arms cannot be limited by any state or federal law; and

**WHEREAS**, we the people of New California believe that a well-regulated militia would consist of all capable citizens of the state between the ages of eighteen and forty-five years, and of those between said ages who shall have declared their intention to become citizens of the United States, residing therein, subject to such exemptions as now exist, or as may hereafter be created, by the laws of the United States or of this state. Nothing would exclude any citizen over forty-five years from keeping and bearing arms for self-defense or the defense of their families; and

**WHEREAS**, the citizens of the California Republic are now forced to live under occupation by a government not of our choosing in violation of the ideals of both the Bear Flag Republic and the Whig Republic of the Federal Union constituting what is nothing less than treason, insurrection, and a state of undeclared war against the citizens of California, the United States; and

**WHEREAS**, the citizens of California, in the tradition of the Founders of the United States, seek to rejoin the United States and live under the tenants of liberty our fathers and grandfathers fought, bled, and died for; and these citizens who support the traditional liberties that are our birthright as Californians and Americans do seek a state of our own to be known as New California State; and

**WHEREAS**, we as the citizens of New California State pray the President of these United States of America exercise his authority under the Insurrection Act of 1807 to end the tyranny being foisted upon United States citizens living in California.

**BE IT RESOLVED** we as the citizens of New California State, having observed the takeover and corruption of our once proud republic, give a clarion warning to the other states of the union that the old California Republic has been the experimental laboratory for what the enemies of liberty seek to export to other states for the destruction of the republican forms of government they hate; and

**BE IT FURTHER RESOLVED** we as the citizens of New California State, having observed their natural rights of self-protection being infringed by the California Republic on its citizens rights to own and bear arms as provided in the second amendment of the United States Constitution and also clarified further by the United States Supreme Court in its 2008 case 'Washington DC vs Heller' that each citizen has the right keep and bear arms for self-defense in New California.

**BE IT FURTHER RESOLVED** the government of California, the current socialist governor and mono-party system along with local officials are following a coordinated design with the intent to actively engage in acts of insurrection against the U.S. Constitution.

**BE IT FURTHER RESOLVED** the **Insurrection Act of 1807** is a United States federal law that governs the ability of the President of the United States to deploy military troops within the United States to put down lawlessness insurrection, and rebellion.

**BE IT FURTHER RESOLVED**, we as the citizens of New California State, declare that the California government in conjunction with the socialist state executive, instituted wherever the current socialist governor has usurped power has created a reign of terror on United States Citizens living in California with the intent to secede from the United States of America and thus destroy the very Union of States which secures our Liberty and Freedom.
