**Re: New California State Joint Resolutions
Constitutional Conventions 1, 2, 3, 4
Assembly and Senate Rules Committees**

Date: May 24, 2019

The 4th Constitutional Convention held on May 17-18, 2019 in Fresno, CA was a major step forward for the New California State (NCS) Legislature. NCS Legislative representatives of both the Assembly and the Senate had identified forty-three (43) issues to be considered for Resolutions that were of major national and state significance.

During the Convention, five (5) resolution issues were selected, “titled” and voted upon to be prepared as Resolutions and voted on as “Joint Resolutions.” Of major significance, the invited guest speakers were in fact “witnesses” who provided testimony to support three of the resolutions presented for consideration.

The resolutions were the first to be issued by the NCS Legislature and are in direct opposition to the State of California’s mono-party legislature and governor’s dictatorial actions. These Resolutions are the beginning of Resolutions planned by the New California State Executive and Legislature.

The Assembly and Senate Rules Committees were established.

These resolutions address the following issues:

- 1. SB 54 the “California Values Act” Sanctuary State**
- 2. Voting**
- 3. 2nd Amendment**
- 4. Threat of Socialism and Communism to New California State**
- 5. Property Rights**

Counties were asked to submit proposed resolutions prior to the Convention. There were 16 counties who submitted resolutions.

At the 4th Constitutional Convention, the Assembly and Senate were tasked to title the resolutions, agree to the titles and vote in joint session.

At the end of the convention on May 18, 2019 the five (5) resolution titles were unanimously approved.

Assembly Members and Senators were tasked to develop the language of the resolutions and come to a consensus in preparation of a vote for each Resolution within the next a thirty day period.

The process to achieve consensus started with the most pressing of resolutions that were timely and which witnesses could be invited to appear.

Basis for Resolutions

NCS Grievances and resolution documents submitted by the NCS County Committees serve as the basis of resolutions to be prepared by the NCS Legislature.

Resolution Submissions

Resolutions were submitted at NCS Constitutional Conventions 1, 2 and 3 by the New California Executive to the Legislature for consideration and Joint Resolution votes.

Resolution Documentation

Written resolutions were submitted by the Executive for Conventions 1, 2 and 3. Resolutions for the 4th Convention were written by the Executive but were not completed in time for submission for consideration.

Assembly and Senate

The Assembly and Senate are tasked with the following:

1. Finalize the (5) titled resolutions and conduct the joint resolution vote to approve the language within the next 30 Days.
3. Assembly and Senate members may choose to use the resolutions written by the Executive for the following resolutions: SB 54, "California Families Act", Voting, Threat of Socialism and Communism to New California
4. 2nd Amendment resolution documents were also written but there were numerous concerns expressed regarding the 2nd Amendment.
5. Property Rights resolution was brought forward to the Senate by the Riverside County Senator Robert Righetti. The Senate voted unanimously to accept the Property Rights Resolution title. Senator Righetti approached the Assembly who also accepted the resolution title and voted unanimously to support a joint resolution.
6. The Assembly and the Senate will each hold three meetings to either accept the resolutions as written, or resolve the language of the resolutions and vote to jointly approve modifications to the resolutions.
7. Establish Assembly and Senate Rules Committees and adoption of Rules.
