An act to ensure elections in the State of New California shall be the honest representation of the will of our citizen voters by maintaining accurate voter rolls that represent only eligible voters and by eliminating opportunities for election manipulation by electronic election systems.

The Constitution of the United States of America is the supreme law of the land. Articles IV, V and VI embody concepts of federalism, describing the rights and responsibilities of state governments and the states in relationship to the federal government. The Constitution's first three words *We the People* affirm that the government of the United States exists by the consent of the people to serve its citizens. The rights under Article IV, Section 4 of the United States Constitution "... shall guarantee to every State in this Union a Republican Form of Government and shall protect each of them against Invasion; and on Application of the Legislature, or the Executive (when the Legislature cannot be convened) against domestic Violence."

In the words of the Declaration of Independence, governments derive "... their just powers from the consent of the governed, ..." Without such consent, governments are tyrannies, unjustly handing out penalties with the usurped power seized by force or manipulation.

This act's costs shall be determined

THE PEOPLE OF THE STATE OF NEW CALIFORNIA DO ENACT AS FOLLOWS:

Section 1. Section (to be determined) of the Elections code shall read:

(Code to be determined) The State of New California shall guarantee only eligible United States legal citizens that domicile in the State have the right to vote and that it is counted representing the will of the voter.

(Code to be determined) All elected officials shall be required to swear to and sign under penalty of perjury, the State's official “Oath of Office” to the Constitutions of the United States and the State of New California. This Oath is a binding compact.

(Code to be determined) The State of New California shall require all elections staff and volunteers take an Oath to ensure “free and fair” elections are conducted securing the outcomes are the will of the people.

(Code to be determined) Those who fail to take their Oath of Office shall not be placed into office nor receive a salary. Those who swear falsely shall be prosecuted for perjury and forever denied public service employment. Officials that abridge the God given rights of the people by promoting, ordering or enforcing mandates that are not constitutional are breaking their sacred Oath of Office and shall be facing felony charges.

(Code to be determined) The State of New California shall challenge the authority of the Federal Government National Voter Registration Act (NVRA) passed in 1993 that creates a national database of all voters by using the Department of Motor Vehicles (DMV) as a primary resource of voter information resulting in the addition of ineligible new voters that includes illegal foreign nationals and non-citizens. DMV updates have also added duplicates of eligible voters to the state's voter rolls. The NVRA authorizes the circumvention of the 10th Amendment of the United States Constitution that guarantees State's Rights. It is the Right and it is the Duty of the State officials to protect the authenticity of election outcomes by ensuring all votes cast represent only eligible registered voters.

(Code to be determined) The State of New California will require the government issued current valid ID to register to vote. All voters must present their authorized valid Voter ID that includes their current picture and signature at the voting precinct on election day in order to obtain and cast a ballot in all elections. All voter roll information shall be maintained for accuracy and protected by secure auditable practices for registrations and updates at the county level prior to every election.

(Code to be determined) When a County Clerk Recorder is running for reelection or another elected position, they must recuse themselves from supervising the said election.

(Code to be determined) All candidates that are running for an elected position shall be listed on the ballot even if they are unopposed to ensure they hold an elected position as selected by the citizen voters and are required to take the Oath of Office prior to being seated.


(Code to be determined) The State of New California shall eliminate the use of electronic devices for any part of the election process. Elections shall be on one day, conducted in local precincts with paper ballots and paper poll books logging each citizen voter participant. All voting and counting shall be conducted at the local polling station unless the voter was unable to attend the election and qualified to be issued an Absentee Ballot.

(Code to be determined) A secure chain of custody process shall be implemented that requires verifying Voter ID names and signatures, the counts of poll books voter tallies, ballot tallies, and candidate vote tallies shall be conducted immediately after the election closes and audited with a recount by a minimum of two witnesses and documented by their signatures.


