The existing State of California Government thus called has not only abused these powers nominally entrusted to it, but, with the connivance and active aid of the executive, has infringed upon or usurped those stated limits of power and exercised other powers, to the manifest injury of the people, which, if permitted, inevitably subjects them to despotism, tyranny and serfdom to the administrative state.

Therefore let it be resolved: If the President of the United States of America should declare an emergency under the International Emergency Economic Powers Act (IEEPA) supported by a Proclamation of a State of Emergency by the Governor of the State of California and/or insurrection is determined to exist in the current California State under the Insurrection Act of 1807. And should the President and the legislative branches act upon the failure of the State of California to carry out the functions of a State Government and fails to provide United States Citizens their Constitutional Rights under Article IV, Section 4 to end the tyranny being foisted upon the United States Citizens living in California State. Be it known that the New California State Government, acting on behalf of all Citizens of California will establish a Restored California Government.

The Restored California Government will consist of an Executive Branch and a Bi-Cameral Legislative Branch of government functioning under the authority of its constitution, and the Citizens of California are determined to live under a State Government in the United States of America, under the Constitution of the United States.

A Resolution of the Senate and Assembly of New California State Establishing a Restored Government of California

WHEREAS, the true purpose of all government is to promote the welfare and provide for the protection and security of the governed, and when any form or organization of government infringes upon those inalienable rights as secured by our "Founding Documents," and proves inadequate for, or subversive of this purpose, it is the right, it is the duty of the PEOPLE to alter or abolish it.

WHEREAS, the existing State of California Government thus called has not only abused the powers nominally entrusted to it, but, with the connivance and active aid of the executive, has infringed upon or usurped and exercised other powers, to the manifest injury of the people, which, if permitted, will inevitably subject them to despotism, tyranny and serfdom to the administrative state.

WHEREAS, we the citizens of California are determined to live under a state government in the United States of America and under the Constitution of the United States.

NOW THEREFORE, BE IT RESOLVED, that in the event of a failure of the State of California to carry out the functions of a State Government and, or if, the President of the United States of America should declare an emergency under the International Emergency Economic Powers Act (IEEPA) supported by a Proclamation of a State of Emergency by the Governor of the State of California and/or insurrection is determined to exist in the current California State under the Insurrection Act of 1807. And should the President and the legislative branches act upon the failure of the State of California to carry out the functions of a State Government and fails to provide United States Citizens their Constitutional Rights under Article IV, Section 4 to end the tyranny being foisted upon the United States Citizens living in California State. Be it known that the New California State Government, acting on behalf of all Citizens of California will establish a Restored California Government.

BE IT FURTHER RESOLVED, that The Reformed California Government will consist of an Executive Branch and a Bi-Cameral Legislative Branch of government, functioning under the authority of its constitution, and the Citizens of California are determined to live under a State Government in the United States of America, under the Constitution of the United States.
