# State of New California **NOTICE** <u>TO ALL CALIFORNIANS!</u> <u>Chapter II</u> **Grievance 81**

**NOVEMBER 9, 2021** 

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

## **Statement of Intent**

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

*"We are determined to live under a State Government in the United States of America and under the Constitution of the United States."* 

## New California Declaration of Independence of January 15, 2018 states:

"Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

When a long train of abuses and acts to seize and hold the people's power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their **Right, it is their Duty**, to throw off such Government, and to provide new Guards for their future security.

### **Preamble of the New California State Constitution states:**

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

### **First Amendment of the United States Constitution states:**

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Fourth Amendment of the United States Constitution states:

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

The Counties of New California State brought forward 95 Chapter I Grievances between January 2018 and November 2019. On April 28, 2020 New California State will issue 95 additional Chapter II Grievances to be announced in public on Tuesdays at 11:00 am.

# Grievance 81

### **Declaration of Grievance Statement of Facts**

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

## California State Government Violates the Following: United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

### **United States Constitution Article VI**

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

### **First Amendment, United States Constitution**

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

### Fourteenth Amendment, United States Constitution

<u>Section 3</u>. No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.

## **ORDER OF THE DAY FIND THE MONARCH**

From Grievance 80:

### **U.S.** Constitution Article IV Section 4 States the following:

"The United States shall guarantee to every state in this union a republican form of government, <u>and shall protect each of them against</u> <u>invasion</u>; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

Protection "Against Invasion" is one of the founding principals our Founding Fathers laid down in the Constitution in 1787. It was James Madison in April 1787 who had suggested that "an article ought to be inserted expressly guaranteeing the tranquility of the states against internal as well as external danger. . . Unless the Union be organized efficiently on republican principles innovations of a much more objectionable form may be <u>obtruded</u>".

**Obtruded; meaning to** force or impose (oneself, one's ideas, etc.) without warrant or request.

In California the monarch Gavin Newsom has gained supreme powers over the people since the U.S. Constitution's Article IV reverse engineering was completed on September 14, 2021 in a fraudulent recall vote.

In Arizona Governor Doug Ducey has left the country to go to China and is nowhere to be found so his Secretary of State Katie Hobbs has assumed command. Because Governor Ducey left the country to go to China (who heavily funded his own personal business) all the executive powers reserved to the governor has now shifted over to Hobbs. Because the legislature is not in session Hobbs has dictatorial "rule" as would any *monarch* over the people of Arizona.

From Jordan Conradson of the Gateway Pundit:

"The Arizona Legislature is not currently in session, therefore Hobbs does not have the power to approve or veto bills. However, she now has executive authority over Arizona and with that, the power of executive orders. With these executive powers, Hobbs also holds the Governor's Emergency Powers, leaving her unrestrained".

Hobbs, like Newsom were elected in 2018 were both heavily supported by George Soros and China. Their election's show, with the proper algorithm applied to the Dominion election system they both lost by large margins in 2018.

In Illinois Governor J.B. Pritzker has ignored state law and assumed dictatorial powers with the support of the state courts since March of 2020 due to the covid scare.. Pritker is a dictator and a monarch in Illinois. Nevada's Governor Steve Sisolak has done the same as Pritker so he to is a dictator monarch in Nevada.

Yet other states such as Michigan, Minnesota, Wisconsin, New York, New Jersey, New Hampshire, Oregon, Washington, Virginia, Pennsylvania, Hawaii, New Mexico, all are monarchies as well under covid orders.

#### From Grievance 80:

June 1787, at Convention the Founders realized that in order to maintain freedom from invasion and domestic violence you had to have a republican form of government....."a republican government must be the basis of our national union; and no state in it ought to have it in their power to change its government into a <u>monarchy</u>".

### Monarchy; meaning undivided rule or absolute <u>sovereignty</u> by a single person".

What is apparent is a fraudulent election system is one of the main mechanisms that has brought this nation so many monarchs. Driven by modern globalist *oligarchs* such as George Soros, Bill Gates and Jack Dorsey they have created a situation in the U. S. where monarchs acting in typical totalitarian fashion are on the brink of seizing all power and thus destroying the U.S. Constitution's influence.

Oligarchy: form of power structure in which power rests with a small number of people. These people may or may not be distinguished by one or more qualities, like nobility, fame, wealth, education, or corporate, religious, political, or military control.

#### In Grievance 73 we stated:

"But the bigger risk of a Newsom recall victory is increased dictatorial control reinforced by a fraudulent victory. This is what happens in dictatorships all around the world. The fraudulent victory by a "vote of the people" gives Newsom almost endless dictatorial powers. After all the <u>"votes"</u> prove he's the <u>"peoples"</u> choice".

### From Grievance 80:

The fraudulent vote of September 14, 2021 has now given the United States its first monarch. Supported by a cast of deep state operators including <u>58 County Clerk</u> <u>Recorders</u> who certified the fraudulent elections in their own counties. An equally corrupted <u>County Board of Supervisors</u> who all share in the violations of their oaths of office are also to blame.
